### What now?

Bill 124 limited increases in wages and total compensation to no more than 1% a year for a 3-year period.

When the law was struck down on November 29 it meant that the restrictions on bargaining more than 1% don't exist, unless the province appeals.

CUPE has agreed with the Ontario Hospital Association that if a the court strikes down Bill 124, bargaining on wages for the period that would have been covered by the bill can begin again.

## Government to appeal

The Ford government said that it will appeal the court decision. It is not clear what impact an appeal would have on delaying a return to the bargaining table to renegotiate the 1% and 1% wage increases recently awarded by a board of arbitration to CUPE members under Bill 124 before it was struck down.

### Court strikes down Bill 124

The Ontario Superior Court of Justice struck down Bill 124 on November 29. Unions will campaign against the government's announcement to appeal the decision.

"I declare the act to be void and of no effect," Justice Markus Koehnen wrote.

"On my view of the evidence, Ontario was not facing a situation in 2019 that justified an infringement on Charter rights," the justice added.

"Unlike other cases that have upheld wage restraint legislation, Bill 124 sets the wage cap at a rate below which employees were obtaining in free collective bargaining negotiations."
